(FNI) announced today, 20 February 2017, that its subsidiary, Platinum Group Metals Corporation (PGMC), has been awarded an annual contract to supply 1 million wet metric tons (WMT) to Baosteel Resources International Co., Ltd. (Baosteel Resources) at prevailing market price. PGMC has been supplying Baosteel Resources with high to medium grade saprolite ore and medium to low grade limonite ore since 2014.
