### Item 9. Other Events

We advise the Commission that, as disclosed with the PSE Edge on November 10, 2016, Ipilan Nickel Corporation (INC), an affiliate of FNI, has entered into a Loan Agreement with Baiyin International Investment Ltd (BII) for the aggregate amount of US\$20 million. The loan, which is covered by FNI's corporate guarantee, is intended to fund INC's capital expenditures and working capital. BII is a subsidiary of a Chinese state-owned company, Baiyin Nonferrous Group Co. Ltd (Baiyin). The execution of the loan follows the Memorandum of Cooperation signed by FNI and Baiyin earlier.
